Prudential Financial, Inc. ("Prudential") indirectly owns 100% of equity interests of

Jennison. As a result, Prudential may be deemed to have the power to exercise or to direct the exercise of such voting and/or dispositive power that Jennison may have with respect to the Issuer's Common Stock held by the Managed Portfolios.
